Surface Science Spectra is published annually by AVS through the American Institute of Physics (AIP). It is an official publication of AVS devoted to archiving surface science spectra of scientific and technological interest. *Surface Science Spectra* provides a vehicle for the publication of reference, comparison, and technical spectra from surface analysis techniques such as Auger and x-ray photoelectron spectroscopy. Spectra from all classes of materials will be published. Archived data can be downloaded by a single click to give subscribers access to spectra at their 'as-acquired' resolution.

Submit Contributions to the AVS Publications Office of *Surface Science Spectra*, 100 Park Drive, Suite 105, Caller Box 13994, Research Triangle Park, North Carolina 27709-3994. Before preparing a submission, authors should first consider uploading articles and related data using the Web-based Contributors Form (<http://www.publishinsss.com/>). Since SSS is devoted to archiving surface science spectra, submission of spectra which have been previously published in another form, such as a figure in a regular scientific journal article, is permissible. Upon receipt of a submission the Editor will send the author a Transfer of Copyright Agreement form. This must be completed by the author and returned to the Editorial Office prior to publication of an accepted submission in the journal *Surface Science Spectra*. This written transfer of copyright, which previously was assumed to be implicit in the act of submitting data, is necessary under the 1978 copyright law in order for AVS and AIP to continue disseminating research results as widely as possible. Further information may be obtained from AIP.

Publication Charges: To support the cost of wide dissemination of research results through publication of journal pages and production of a database, the author's institution is requested to pay a page charge of \$25 per page. The charge, if honored, entitles the author to 50 free reprints. For Errata the minimum page charge is \$10, with no free reprints.

Copying: Single copies of individual articles may be made for private use or research. Authorization is given to copy articles beyond the free use permitted under Sections 107 and 108 of the U. S. Copyright Law, provided that the copying fee of \$30.00 per copy per article is paid to the Copyright Clearance Center, 222 Rosewood Drive, Danvers, MA 01923, USA, www.copyright.com. (Note: The ISSN for this journal is 1055-5269.)

Authorization does not extend to systematic or multiple reproduction, to copying for promotional purposes, to electronic storage or distribution, or to republication in any form. In all such cases, specific written permission from AIP must be obtained.

Permission for Other Use: Permission is granted to quote from the journal with the customary acknowledgment of the source. To reprint a figure, table, or other excerpt requires the consent of one of the authors and notification to AIP.
